

Survival Gear on the Claims

President Garry Devlin has a list of suggested essentials that should be kept in a car while going out prospecting on the Valley Prospectors Claims.

The items that should be in your vehicle are a blanket, shovel, whistle, flashlight, non-perishable food such as fruit bars, peanut butter and crackers, life savers candy,etc. 3 gallons of drinking water per day, Gatorade. A bucket, feminine pads for large cuts, duct tape, tie wire, first aid kit, jumper cables, tool box, spare tire with air in the tire. A fully charged cell phone and the cell phone charger. A roll of quarters and some one dollar bills for the coin operated machines.

Campfire Permits on the Valley Claims

Some of the Valley Prospector Claims require a campfire permit. The claims on the Yuba River require a campfire permit. Cal Fire has the permit process online and you need to watch a video and answer eight questions and you get the campfire permit for free. Dane's Stories of the Yuba River

In 1965 my Dad and I completed the construction of our family vacation cabin approximately 1 mile upriver from the Union Flat campground on the North Fork of the Yuba River where Valley Prospectors owns the claims "Gold Ventures and the Picket 111 placer claims".

From 1965 on, my dad and I began our dredging operations on our property with a 4 inch underwater Keene Engineering dredge. An effective machine for bigger nuggets but I'm sure we lost much of the smaller gold, and we never kept or processed our black sands. The removable sluice was about 6"x14" and we frequently found 'picker' sized nuggets in the last riffles.

We made several good prospecting friends that trained us to be successful in sniping, prospecting, and dredging. Kenny Vance, Bep Athenation, and Lucian King spent many days and weeks with us for the first couple years. With their guidance, my dad and I regularly found enough gold to pay expenses, a few cabin loan payments each summer, and we still put a little cash in our pockets at the end of summer. Being illegal at the time to own more than an ounce of raw gold, we would sell our larger nuggets to jewelers in Nevada City and Grass Valley for up to \$50.00 an ounce. Black market of course. The smaller 'fines' were sold to Knott's Berry Farm for \$32.00 an ounce. They would "seed" their gold panning paid operation for the general public entertainment.

In August of 1967, while sniping my fishing hole in front of our cabin, I located a 5 foot diameter round hole in the bedrock. After removing a sizable boulder with an old WW2 bomb winch, I started to dredge down through the fairly lose rock, sand, and gravels. By noon I had cleared down to about 6 feet deep when my dad took over the dredging. Within 20 minutes, and with the sun directly overhead, my dad made one quick pass with the dredge to reveal a gleaming layer of gold that lit up the hole we had excavated. I saw the gold reflecting from my fishing platform well above the river. Within seconds, huge bubbles were escaping from my dads' regulator as he screamed underwater. I heard nothing but I guessed at his excitement. 4 hours later after sitting on the bottom of this deep hole picking up gold with his fingers and tweezers, my dad returned to the surface with a jar full of gold. Almost 18 ounces total between hand and dredging recovery of beautiful nuggets and smaller pickers. The best 1 days take in the many years of dredging in front of our cabin. The pictures I have included show our cabin and the gold my dad recovered by hand. The sluice box recoveries were not processed yet and never photographed unfortunately.

I always found it amazing how much gold weighs while appearing to be smaller amounts. An average day of sniping would net me anywhere from ¼ ounce to over 2 ounces on a good day. But it always looked smaller in weight than it actually was. 5 days a week we would dredge, Friday nights' dad went to Reno gambling, and Saturday was my sniping day. Sundays I would rest up and go fishing.

Starting at 13 years old and up, I personally made enough money each summer to finally acquire an almost complete coin and my choice of a small gun collection, and still had money left over for school clothing, lunches and a little entertainment money. Looking back today, I wish I had kept every ounce I found.
